Stage 1: Preliminary Bid Responsiveness Assessment

These are mandatory documents to be attached to the tender document. Absence of any of these documents will lead to the bidder being disqualified and will not be considered proceed to the next stage of evaluation.

Stage 2: Technical Evaluation Stage

The technical evaluation is weighted out of 100 points with a pass mark of 30 points. Any bidder scoring 30 points and above in the technical evaluation will be considered for financial evaluation stage. Any bidder scoring below 70 Points in the Technical Evaluation will be disqualified from further evaluation.
